BOARD CORRESPONDENCE:

Philip Myers requested a reduction in units he is paying at the Old Saratoga Inn  
Commissioner Hughes made a motion to remove the 2 Units charged for the hot dog stand that no longer operates motion was 2<sup>nd</sup> by Chairman Drew all in favor. Mr. Myers also requested to have units reduced for the motel rooms the board said that there is a set law of Units that have to be charged, but they will discuss the issue no changes for now.

JCF PLANT OPERATIONS:

Jake Fort JCF Water Management said there is a detect at the Schuylerville Plant for PFAS's and the water will have to be tested quarterly, he is calling contractors to look at the roof at the Victory Plant and they have done a lot of cleaning. Jake would like advanced notice about hydrants that are going to be flushed, the Clerk Gina Colburn will reach out to the Chief Water Operator and lead agency to request that they inform JCF and publish it on their website. Tim Healy made a motion to approve a purchase from FW Webb if it is over \$500.00 It was 2<sup>nd</sup> by Chairman Drew and all in favor.

OLD BUSINESS:

Commissioner Healy signed the current contract with JCF and the addendum that goes with it due to the fact he was the Chairman at the time that the contract was agreed upon. Edwin Sullivan Phillip Dixon (Attorney) says that the Water Department owns the pipes that are on Mr. Sullivan's land which gives them the right to go on the property. Commissioners Dennison and Healy feel that this should be left alone and do not feel that pursuing billing Mr. Sullivan for this property is worth the problems that may come from it.

NEW BUSINESS:

Report from Gilman Albert Building/Code Officer stating that the four new units at the 1 Ferry Street location are camps the board would like to discuss further after Chairman Drew talks to Mr. Albert again, hold off to next meeting. 2021 government accounting class for Clerk Gina Colburn motion made by Chairman Drew 2<sup>nd</sup> by Commissioner Dennison all in favor. Schuylerville/ Victory's credit card has Commissioner Healy's name on it the board has requested that clerk Gina Colburn request a new one and cancel this one to remove Commissioner Healy's name. Hydrants that need to be replaced Chairman Drew spoke to Kubricky and will call others to see about a quote to replace them. Don Fish has home advertised with having 3 Units but is only paying for 1 Unit. Chairman Drew made a motion to increase the Units 2<sup>nd</sup> by Commissioner Dennison all in favor.
